



Social Innovation: new Nordic approaches for tackling demographic and welfare challenges

Nordregio, Stockholm 16th of September, 2014

The Nordic countries and regions are facing severe demographic changes such as stagnation or reduction of the share of working age population, out-migration and significant increase in the share of population over the age of 65. The workshop “Social Innovation: new Nordic approaches for solving demographic and welfare challenges” explores the potential for social innovation to identify and implement new ways to address durably this demographic shift and how it affects the welfare challenges of local, regional and national authorities in the Nordic countries.

The concept of social innovation has been around in the academic discourse for a while now, but it has gain momentum recently to its emergence in the European policy discourse. Indeed, the concept is included in European policy initiatives such as the Innovation Partnership for Active and Healthy Ageing, and Cohesion Policy, as well as Horizon 2020. It is about the development and implementation of new ideas (products, services and models) to meet social needs and create new social relationships or collaborations, i.e. using a more participatory approach.

The workshop is part of the work of the Nordic Council of Ministers’ Nordic Working Group on Demography and Welfare, which aims to form a joint Nordic platform for producing knowledge and exchanging experiences regarding the challenges and opportunities induced by the current demographic and labour market related changes. The target groups of the workshop are Nordic policy-makers, practitioners, planners and researchers involved and interested in issues related to demographic change at national, regional and local levels of government.

The objectives of the workshop are:

- To bring together policy-makers and practitioners from different levels of government as well as the research community to discuss the potential of social innovation in addressing demographic change in the Nordic countries
- To provide a platform for exchange of experience on applying the social innovation approach in meeting demographic challenges
- To inspire new collaborative governance approaches for securing the provision of services in all parts of the Nordic countries
